All appointed Coaches must comply with the norms of the **Government of India** and the **Indian Olympic Association**.

### 3. Suspension of CEO

Following the February 2025 election, CEO **Mr. Prasenjit Singha** has been found involved in activities against Federation interests in association with anti-Federation groups. After reviewing all documents, the Board unanimously resolved to **suspend him until valid clarification and written apology are submitted**.

### 4. State Tripura Suspension

All State Associations except **Tripura** have submitted required verification documents. Tripura State is **suspended until submission of valid documentation**.

### 5. Amendment of Federation Name

Among the following proposed names:

- UNITED MUAYTHAI ASSOCIATION – INDIA
- UNITED MUAYTHAI ASSOCIATION OF INDIA
- UNITED MUAYTHAI INDIA ASSOCIATION

One will be finalized **within one month**.

It was also resolved that the post **Treasurer** may be titled as **CFO** where **required**.

### 6. Creation of Honorary Post

A new honorary post **CHAIRMAN** will be created within the National Federation.

### 7. National Championship Venues (2026)

- **Senior Nationals 2026:** Hyderabad, Telangana, January 2026
- **Youth Nationals 2026:** Uttarakhand, June 2026

### 8. National Games

The upcoming **National Games** will be held in Meghalaya.

### 9. Financial Verification

Financial reports relating to OSM, National Championships, and other UMAI activities were **verified and unanimously approved**.

### 10. Resolution of Rajasthan Dispute

After reviewing valid documents submitted by **Muaythai Association of Rajasthan**, all allegations are withdrawn. No further dispute should be raised regarding Rajasthan.

### 11. Restriction on Holding Dual Key Posts

As per norms of Govt. of India and IOA, **no person shall hold key posts in more than one Federation or State Association simultaneously.**

### 12. Haryana State Issue

Haryana Muaythai Association distributed **blank certificates** of the 6th UMAI National Muaythai Championship 2025 to unauthorized persons. The Association must submit justification **within 7 days**. Failure to do so will lead to disciplinary action.

### 13. Affiliation of Muaythai Association Delhi

Based on submitted Society Registration and recognition by Delhi Olympic Association, affiliation to **Muaythai Association Delhi** is **approved**.
