Subject: Suspension from All Official Duties and Positions of UMAI

Dear Sir,

This is to formally notify you that the Executive Board of the United Muaythai Association - India (UMAI), in its Emergency Annual General Meeting (AGM) held on 22nd November 2025 at the Press Club of India, New Delhi, has unanimously resolved to suspend you from all official duties, roles, and responsibilities within UMAI with immediate effect.

This action has been taken in view of repeated anti-association activities, including but not limited to actions and decisions that were deemed detrimental to the unity, reputation, and smooth functioning of UMAI. Despite prior discussions and opportunities for clarification, these concerns persisted, leaving the Executive Board with no alternative.

Your suspension shall remain in force until the completion of a full inquiry by the Internal Disciplinary Committee which is as follows:

Chairman: Mr. Anupam Mahata, Vice Chairman: Mr. Angelus Sun

Members: Mr. Bal Krishna Shetty, Mr. Amit Singh, Ms. Nikita Mirchandani (Advocate- Rajasthan High Court)

You are hereby directed:

- 1.To refrain from exercising any authority or representing UMAI in any official or unofficial capacity.
- 2.To surrender all UMAI documents, digital access and official materials in your possession to the Disciplinary Committee Chairman within 48 hours of receiving this notice.
- 3.Not to interact with state associations, athletes, officials, or external bodies on behalf of UMAI during the suspension period.

Failure to comply with these directives may lead to further disciplinary action as per UMAI constitutional guidelines.

The Executive Board assures that the inquiry will be conducted fairly, impartially, and in accordance with UMAI's established procedures.

You should submit a written explanation to the Disciplinary Committee within 15 days of this notice.
